Cyflwyniad

Pryfed bychain yw llau pen y deuir o hyd iddynt weithiau yng ngwallt oedolion a phlant. Maent yn byw ar groen y pen neu'n agos iawn iddo- nid ydynt yn crwydro ymhell i lawr coesynna'r gwalt am amser hir iawn, ac nid yw'n 'well' ganddynt unrhyw fath arbennig o wallt. Nid yw'r lleuen yn peri unrhyw effeithiau drwg, ar wahân i gosi ysgafn yn achlysurol.

Maent yn lledaenu drwy gyswilt uniongyrchol gwalt i wallt a phen i ben. Mae o leiaf 60 eiliad yn angenrheidiol i lledaenu'r llau o un i'r llall. Mae trosglwyddo llau o fewn y dosbarth yn gymharol brin. Ar unrhyw un adeg, bydd gan y rhan fwyaf o ysgolion ychydig o ddisgyblion sydd â haint gweithredol gyda llau pen. Y canfyddiad gan rieni a staff yn aml yw bod achos difrifol wedi 'torri allan' gyda llawer o'r plant yn yr ysgol wedi eu heintio – nid dyna fel mae hi bron fyth. Mae'r lefel hefyd yn aros yn gyson yn ystod gwyliau'r ysgol.

Gweithredu

Introduction

Head lice are small insects which are sometimes found in the hair of adults and children. They live on or very close to the scalp - they do not wander far down the hair shafts for very long, and they do not 'prefer' any particular type of hair. The louse causes no ill effects, except occasionally mild itching.

They spread by direct hair to hair and head to head contact, at least 60 seconds is necessary to spread the lice from one person to another. Transmission of lice within the classroom is relatively rare. At any one time, most schools will have a few pupils who have active infection with head lice. The perception by parents and staff is often that there is a serious 'outbreak' with many of the children in the school infected - this is hardly ever the case. Also, the level remains constant during school holidays.

Aims and Objectives of policy

- To provide guidance to schools on the management of head lice
- To outline individuals responsibility in the management of head lice

Implementation

1. The school will offer an annual Health Education session on head lice management to parents and pupils in partnership with the School Health Service. Appropriate literature will be distributed and parents will be informed that it is their responsibility to check their children's hair and to inform the school as soon as possible if head lice are discovered.
2. An infection cannot be confirmed unless a live, moving louse is seen. Staff should report any sightings of head lice to the head teacher.
3. The parents of children recognised as having head lice will be contacted directly. An 'alert' letter will not be sent to other parents.
4. Parents of those individuals recognised with head lice will be given 2 weeks to treat the condition successfully.
5. If the condition persists, such causes will be shared with the school nurse. This is so that, if warranted, confidential contact can be made with the family to offer information, advice and support.
6. A further 2 weeks will be allowed for the condition to be successfully treated under the guidance of the school nurse.
7. All cases which persist after following the above steps will be brought to the attention of the School Welfare Officer and the Social Services.*

*A pupil with head lice will not be excluded from school, the only exception is when the carriage of head lice is a persistent problem and part of a problem with the child's hygiene - the child may then be excluded under provisions of the Education Act until management of the hygiene problem, including the eradication of the head lice, is complete.

Informing Parents

All parents will be informed of the policy initially by letter and new parents will receive a copy of the letter as part of the school welcome pack (see appendix 1). The school prospectus will also include information about the policy.

Monitoring and Reviewing

The governing body will monitor and review the policy as necessary.

Ysgol Gynradd Llandegfan's Head Lice Policy

The number of instances of head lice among the pupils of this school continues to concern parents and teachers. Therefore to assist with dealing with the condition the School Governors have approved the school's head lice policy which sets out the following implementation plan:

1. The school will offer an annual Health Education session on head lice management to parents and pupils in partnership with the School Health Service. Appropriate literature will be distributed and parents will be informed that it is their responsibility to check their children's hair and to inform the school as soon as possible if head lice are discovered.
